The submission deadline is Monday January 16, 2012. All submissions need to be sent to me via email and I will respond to each submission to verify receipt of the submission.

Also, there will be a POSTER SESSION at the Spring 2012 meeting. A call for POSTERS will go out to the KSHP membership by mid-January 2012.
