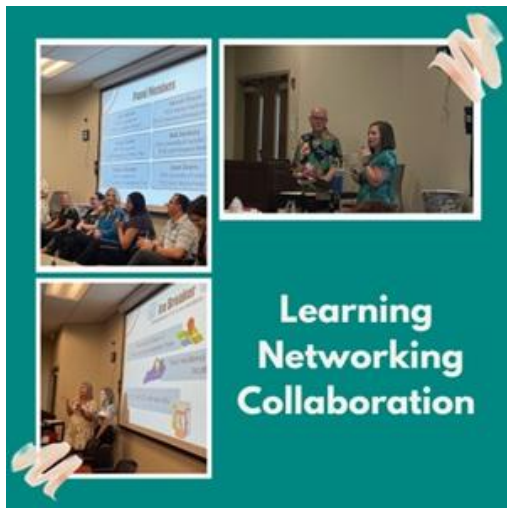
KSHP Fall Meeting - FINAL Call for Speakers!
