ADVOCACY UPDATE from Cornerstone: US Senate HELP Hearing Discusses 340B Program



On October 23rd, members of the US Senate discussed the role of the 340B program in supporting health care access for low-income and uninsured patients, while recognizing the need for greater transparency and oversight. Republicans discussed concerns regarding the program's rapid growth, limited oversight, and potential for abuse or increased health care costs, emphasizing the need for targeted reforms. Democrats prioritized protecting safety net providers,

preventing health care cuts, and ensuring reforms do not harm vulnerable communities. Other topics discussed included the impact of Affordable Care Act (ACA) tax credit expirations, Medicaid cuts, drug pricing reforms, patent practices, and the need for enhanced federal oversight and regulatory authority.

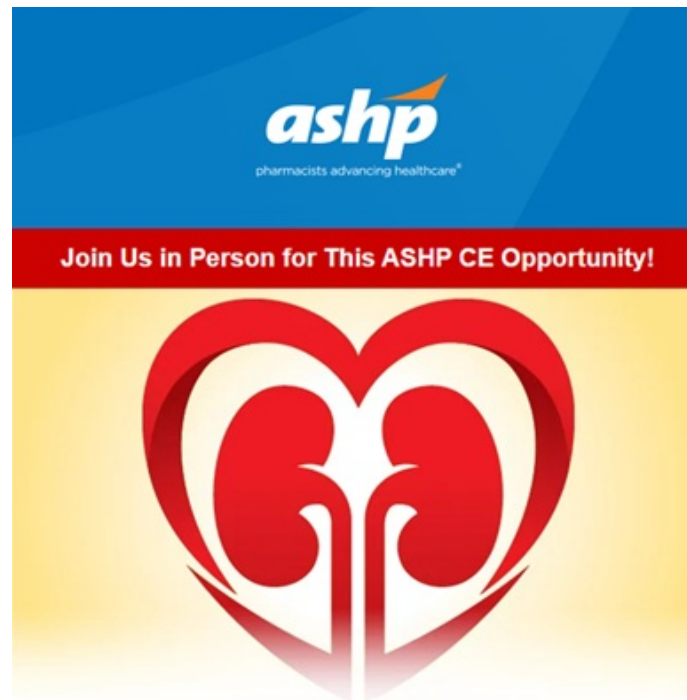


Calling all Residents and Residency Program Directors!
